**EXECUTIVE SESSION (employee matters) – started executive session 5:30 pm.
Woodard would take minutes from Executive session.**

- 3. Approve Minutes from 12/20 Regular monthly meeting – Woodard made the motion to approve adding under the 2022 Council Meetings that the January meeting change from 1/17 to 1/18 needed to be added because it was also voted on, Lewis 2nd, unanimously approved.**
- 4. Approve Agenda – Floyd added Court Clerk Salary (#16), Judge Salary (#17) and Parking at Old Rec Dept (#18). Geter made the motion to approve the agenda with additions, Lott 2nd, unanimously approved.**
- 5. Financial Reports – reports attached. Lott made the motion to accept the reports as given, Lewis 2nd, unanimously approved.**

OLD BUSINESS

- 6. Business License Admin Fee Ordinance – it was presented during December meeting and is ok to adopt. Lott made the motion to adopt the ordinance, Jones 2nd, unanimously approved.**
- 7. Adopt Parade Ordinance amendments – copy of amended ordinance is attached. The following were amended: 1 – impose a \$50 admin fee (currently \$25), 2 - parade hours will be 6-8 during summer months and 6-6 during winter months and, 3 – any churches that are given away food are exempt from the admin fee. Jones made a motion to accept ordinance with amendments, Lott 2nd, unanimously approve.**
- 8. Old Rec. Dept. Update – had a community cleanup day on Saturday, January 15. Have posted in the paper that the city is looking for an architect to overlook the new project. Will reveal bids once received.**

9. **Swearing in of new PD Officer Brandon Zuckerman – City Attorney, R. Clark performed the swearing in of officer.**
10. **R. Clark City Attorney Contract – Copy of contract is attached. Jones made the motion to accept, Cox 2nd, unanimously approved.**
11. **Milton CPA City Accountant Contract – Copy of contract is attached. Lott made the motion to accept, Lewis 2nd, unanimously approved.**
12. **Elect 2022 Mayor Pro Tem – Lewis made a motion to elect Thomas Lott, which he accepted, Woodard 2nd, unanimously approved.**

16. **Court Clerk Salary – Woodard made the motion to raise the court clerk monthly salary from \$275 to \$325, Cox 2nd, unanimously approved.**
17. **Judge Salary – Lewis made the motion to raise the judge salary from \$100/each court to \$200/each court, Woodard 2nd, unanimously approved.**
18. **Parking @ Old Rec Dept – Lott made a motion to notify the WC BOE Superintendent, Couey by letter to give 30-days to find another spot for contractors to park so the city can start the renovation of old rec department, Lewis 2nd, unanimously approved.**
